

The Artistry of Bheki Mseleku Andrew Lilley



Andrew Lilley is an associate professor the at the University of Cape Town, and assistant director of the South African College of Music where he lectures in jazz piano, theory and improvisation. He is a graduate of Berklee College of Music in Boston where he studied with the celebrated hard bop pianist and composer Donald Brown, and with Enja recording artist Bruce Barth. He holds degrees from the University of Cape Town. He is a well-respected member of the South African musical fraternity and appears on numerous recordings with local and international artists. Bheki Mseleku is widely considered one of the most accomplished jazz musicians to have emerged from South Africa. His music has a profound significance in recalling and giving emphasis to that aspect of the African American jazz tradition originating in the rhythms and melodies of Africa.

The influences of Zulu traditional music, South African township, classical music and American jazz are clearly evident and combine to create an exquisite and particularly lyrical style, evoking a sense of purity and peace that embraces the spiritual healing quality central to his musical inspiration.

The Artistry of Bheki Mseleku is an in-depth study of his musical style and includes annotated transcriptions and analysis of a selection of compositions and improvisations from his most acclaimed albums including 'Celebration', 'Timelessness', 'Star Seeding', 'Beauty of Sunrise' and 'Home at Last'. Mseleku recorded with several American jazz greats including Ravi Coltrane, Joe Henderson, Pharoah Sanders, Charlie Haden, Billy Higgins and Abbey Lincoln. His music serves as a vital link



A Brutal State of Affairs The Rise and Fall of Rhodesia Henrik Ellert and Dennis Malcolm Anderson



Henrik Ellert was born in Denmark but grew up in Kenya during the Mau Mau emergency. He came to Zimbabwe in 1961 and joined the police force in 1964, initially serving two years in the uniformed branch and stationed in Shabani and Hartley, where he gained his first experience with the nationalist guerrilla insurgency after the killing of the Viljoens by ZANLA in 1966.

Dennis Malcolm Anderson was born in London in 1930. Having moved to Rhodesia, he attested in the BSAP on 28 October 1956 and initially served in the uniformed branch at Rhodesville, Salisbury, later joining the CID and then Special Branch, where he became closely associated with nationalist leaders during the course of political rallies in the 1960s. A Brutal State of Affairs analyses the transition from Rhodesia to Zimbabwe and challenges Rhodesian mythology. The story of the BSAP, where white and black officers were forced into a situation not of their own making, is critically examined.


The liberation war in Rhodesia might never have happened but for the ascendency of the Rhodesian Front, prevailing racist attitudes, and the rise of white nationalists who thought their cause just. Blinded by nationalist fervour and the reassuring words of the Ministry of Internal Affairs and army commanders, the Smith government disregarded the advice of its intelligence services to reach a settlement before it was too late.

By 1979, the Rhodesians were staring into the abyss, and the war was drawing to a close. Salisbury was virtually encircled, and guerrilla numbers continued to grow. A Brutal State of Affairs examines the Rhodesian legacy, the remarkable parallels of history, and suggests that Smith's Rhodesian template for rule has, in many instances, been assiduously applied by Mugabe and his successors.

Basel Mission Education in Cameroon: 1886-1968 Mathew B. Gwanfogbe



Dr. Mathew B. Gwanfogbe is currently the Vice-Chancellor of the Bamenda University of Science and Technology. He was previously the Director-delegate of the Ecole Normale Supérieure (ENS Annex), Bambili. He is a member of the Cameroon Historical Society, editor-inchief of the Pantikar Journal of History and a member of the British History of Education Society. He is a Knight of the Cameroon Order of Merit and a longstanding member of the Bali Historical Society. Gwanfogbe holds a PhD in History from the University of London and has published widely on the history of education in Cameroon.

This volume examines the relationships between the German colonial administration, the Basel Mission, the British Baptist Missionary Society and other missionary societies that characterized the setting up of Basel Mission education in Cameroon against the backdrop of intense rivalry.



The Mapungubwe Institute for Strategic Reflection (MISTRA) was founded by a group of South Africans with experience in research, academia, policy-making and governance who saw the need to create a platform of engagement around strategic issues facing South Africa. It is an Institute that combines research and academic development, strategic reflection and intellectual discourse. It applies itself to issues such as economics, sociology, history, arts and culture and the logics of natural sciences. *Africa and the World: Navigating Shifting Geopolitics* is one of the first books to analyse the global geopolitical landscape from an African perspective, with a view to the opportunities and challenges facing the African continent. Authors in this edited volume argue for the need to reimagine Africa's role in the world.

As a cradle of humanity, a historical fountain of profound scientific knowledge, an object of colonial conquest and, today, a collective of countries seeking to pool their sovereignties in order to improve the human condition, Africa has a unique opportunity to advance its own interests. Authors reflect on all these issues; they outline how developments in the global political economy impact on the continent and, inversely, how Africa can develop a strategic perspective that takes into account the dynamics playing out in a fraught global terrain.


Central to this evaluation is the notion of 'island Africa': a vast island – with resources that extend into the oceans around it – that is a strategic centre by virtue of its geographic location, its endowments and its long-term potential. Authors assert that the positioning of 'island Africa' presents unique political, security and geo-economic benefits. Yet they also acknowledge that, as has happened historically, these very advantages can serve as a basis for new forms of domination and exploitation. In addition, this volume takes into account the sociopsychological factors that influence how nations of the world receive and interpret the present, and assess prospects for the future.

The authors go beyond analysis of what is, to venture concrete proposals on what can be, with Africa exercising its agency. This volume contributes to what should be an ongoing effort to analyse geopolitics with Africa as a critical frame of reference.

African Personhood and Applied Ethics

Motsamai Molefe



Motsamai Molefe (PhD) is a Senior Researcher at the Centre for Leadership Ethics in Africa (CLEA) at the University of Fort Hare. His research focuses on African Ethics, Bioethics, Development Studies, Environmental Ethics, and Social and Political Philosophy. He is the author of An African Philosophy of Personhood, Morality and Politics published by Palgrave Macmillan.

Recently, the salient idea of personhood in the tradition of African philosophy has been objected to on various grounds.

Two such objections stand out – the book deals with a lot more. The first criticism is that the idea of personhood is patriarchal insofar as it elevates the status of men and marginalises women in society. The second criticism observes that the idea of personhood is characterised by speciesism. The essence of these concerns is that personhood fails to embody a robust moral-political view.

African Personhood and Applied Ethics offers a philosophical explication of the ethics of personhood to give reasons why we should take it seriously as an African moral perspective that can contribute to global moral-political issues. The book points to the two facets that constitute the ethics of personhood – an account of (1) moral perfection and (2) dignity. It then draws on the under-explored view of dignity qua the capacity for sympathy inherent in the moral idea of personhood to offer a unified account of selected themes in applied ethics, specifically women, animal and development.



Beyond Tenderpreneurship Rethinking Black Business and Economic Empowerment MISTRA



The Mapungubwe Institute for Strategic Reflection (MISTRA) was founded by a group of South Africans with experience in research, academia, policy-making and governance who saw the need to create a platform of engagement around strategic issues facing South Africa. It is an Institute that combines research and academic development, strategic reflection and intellectual discourse. It applies itself to issues such as economics, sociology, history, arts and culture and the logics of natural sciences. Black Economic Empowerment (BEE) policies have been a central pillar of attempts to overcome the economic legacy of apartheid. Yet, more than two decades into democracy, economic exclusion in South Africa still largely reflects the fault-lines of the apartheid era.

Current discourse often conflates BEE with the so-called

'tenderpreneurship' referred to in the title, namely the reliance of some emergent black capitalists on state patronage. Authors go beyond this notion to understand BEE's role from a unique perspective. They trace the history of black entrepreneurship and how deliberate policies under colonialism and its apartheid variant sought to suppress this impulse. In the context of modern South Africa, authors interrogate the complex dynamics of class formation, economic empowerment and redress against the backdrop of broader macroeconomic policies. They examine questions relating to whether B-BBEE policies are informed by strategies to change the structure of the economy.

These issues are explored against the backdrop of the experiences of other developing countries and their journeys of industrialisation. The relevant black empowerment experiences of countries such as the United States are also discussed. The authors identify policy and programmatic interventions to forge the non-racial future that the constitution enjoins South Africans to build.





As an activist in residence, she dialogues with the students about their aspirations and encourages them to become artisans of peace and justice. The Challenge of African Potentials Conviviality, Informality and Futurity Edited by Yaw Ofosu-Kusi & Motoji Matsuda



Yaw Ofosu-Kusi is Associate Professor of Social Studies and Dean of the Faculty of Social Sciences of the University of Education, Winneba, Ghana.

Motoji Matsuda is Professor in the Graduate School of Letters at Kyoto University. This collection of articles is based on presentations and discussions at the 2018 African Potentials Forum, held in Accra, Ghana.

This forum was a part of the African Potentials Project, which aims to clarify the latent problem-solving abilities, ways of thinking, and institutions that have been created, accumulated, unified, and deployed in the everyday experiences of Africans. The notion of Africa's latent power/potential is not related to romanticisation of the traditional knowledge of African society and its institutions as fixed, essentialised 'magic wands'. This notion also raises objections against political dogmas that seek to smoke out and eliminate thought and values originating in Western modernity. The keyword of the Accra Forum was futurity. Africa's future is laden with possibilities, latent power, and potential. It is bright and hopeful but, simultaneously, bleak and thought-provoking. For nascent democracies and economically challenged communities, the value of this potential lies not in its static qualities but in how these qualities can be harnessed and translated into beneficial practical outcomes. As a concept, 'potential' connotes a time to come; a futurity that is full of known and unknown possibilities, challenges, and opportunities.

Francis B. Nyamnjoh joined the University of Cape Town in August 2009 as Professor of Social Anthropology from the Council for the Development of Social Science Research in Africa (CODESRIA), Dakar, Senegal, where he served as Head of Publications from July 2003 to July 2009. He has taught sociology, anthropology and communication studies at universities in Cameroon and Botswana, and has researched and written extensively on Cameroon and Botswana.

Joel A. Carpenter is a Senior Research Fellow at the Nagel Institute for the Study of World Christianity, Calvin University, Grand Rapids, USA. This volume brings together seven empirically grounded contributions by African social scientists of different disciplinary backgrounds. The authors explore the social impact of religious innovation and competition in present day Africa.


They represent a selection from an interdisciplinary initiative that made 23 research grants for theologians and social scientists to study Christianity and social change in contemporary Africa. These contributions focus on a variety of dynamics in contemporary African religion (mostly Christianity), including gender, health and healing, social media, entrepreneurship, and inter-religious borrowing and accommodation.

The volume seeks to enhance understanding of religion's vital presence and power in contemporary Africa. It reveals problems as well as possibilities, notably some ethical concerns and psychological maladies that arise in some of these new movements, notably neo-Pentecostal and militant fundamentalist groups. Yet the contributions do not fixate on African problems and victimization. Instead, they explore sources of African creativity, resiliency and agency. The book calls on scholars of religion and religiosity in Africa to invest new conceptual and methodological energy in understanding what it means to be actively religious in Africa today.


Crimes of Capitalism provides a glimpse of this period through contemporary press cuttings. It also highlights the fact that the crimes of Kenya's first two Presidents should be understood not only as evil actions of the individuals concerned. The ruling class and their party, KANU, that they nurtured became the agents of imperialism which sought to impose capitalism on the country and to suppress the growing calls for socialism.

The material from which these cuttings are taken are available in Nairobi's Ukombozi Library, 'Kenya's First Socialist Library' as Rosa Luxemburg Stiftung describes it. Vita Books and the Ukombozi Library will continue to use such documents to highlight other hidden aspects of Kenya's history in future issues of the Research and Documentation Series.

Crossroads of Culture

Christianity, Ancestral Spiritualism, and the Search for Wellness in Northern Malawi Eric Lindland



Eric Lindland, Ph.D. is a cultural anthropologist specializing in the anthropology of religion. The son of American Baptist missionaries, he grew up in Sweden, Norway, DR Congo, and the U.S. He received his doctorate in anthropology from Emory University and now lives and works outside of Washington, DC. Combining history, ethnography, and culture theory, this book explores how residents in northwestern Malawi have responded over time to the early missionary assertion that local religious and healing practices were incompatible with Christianity and western medicine.

Crossroads of Culture details how local agents, in the past and today, have constructed new cultural forms that weave facets of ancestral spiritualism and divination with Christianity and biomedicine. Alongside a rich historical review of the late-19th century encounter between Tumbuka-speakers and the Scottish Presbyterians of the Livingstonia Mission, the book explores the contemporary therapeutic dance complex known as Vimbuza and considers two case studies, each the story of a man confronting illness and struggling to understand the roots and meaning of his afliction. In the process, the book considers the enduring missiological and anthropological topics of conversion and syncretism, and questions the assertion by some scholars that Western missionaries in Africa have been successful agents of religious hegemony.



Positing the notions of coloniality of ignorance and geopolitics of ignorance as central to coloniality and colonisation, this book examines how colonialists socially produced ignorance among colonised indigenous peoples so as to render them docile and manageable.

Dismissing colonial descriptions of indigenous people as savages, illiterate, irrational, prelogical, mystical, primitive, barbaric and backward, the book argues that imperialists/colonialists contrived geopolitics of ignorance wherein indigenous regions were forced to become ignorant, hence containable and manageable in the imperial world. Questioning the provenance of modernist epistemologies, the book asks why Eurocentric scholars only contest the provenance of indigenous knowledges, artefacts and scientific collections. Interrogating why empire sponsors the decolonisation of universities/ epistemologies in indigenous territories while resisting the repatriation/ restitution of indigenous artefacts, the book also wonders why Westerners who still retain indigenous artefacts, skulls and skeletons in their museums, universities and private collections do not consider such artefacts and skulls to be colonising them as well.

The book is valuable to scholars and activists in the fields of anthropology, museums and heritage studies, science and technology studies, decoloniality, policymaking, education, politics, sociology and development studies.

Decolonising the Academy A Case for Convivial Scholarship Francis B. Nyamnjoh





Recurrent clamours by students and academics for universities in Africa and elsewhere, to imbibe and exude a spirit of inclusion are a continual reminder that universities can and need to be much more convivial.

Processes of knowledge production that champion delusions of superiority and zero-sum games of absolute winners and losers are elitist and un-convivial. Academic disciplines tend to encourage introversion and emphasise exclusionary fundamentalisms of heartlands rather than highlight inclusionary overtures of borderlands. Frequenting crossroads and engaging in frontier conversations are frowned upon, if not prohibited. The scarcity of conviviality in universities, within and between disciplines, and among scholars results in highly biased knowledge processes. The production and consumption of knowledge are socially and politically mediated by webs of humanity, hierarchies of power, and instances of human agency. Given the resilience of colonial education throughout Africa and among Africans, endogenous traditions of knowledge are barely recognised and grossly underrepresented. What does conviviality in knowledge production entail? It involves conversing and collaborating across disciplines and organisations and integrating epistemologies informed by popular universes and ideas of reality. Convivial scholarship is predicated upon recognising and providing for incompleteness - in persons, disciplines, and traditions of knowing and knowledge making.

From 1913 to 1920, the Molteno-Murray family published a private journal called "Chronicle of the Family".

It appeared three times a year, providing news of the family scattered throughout South Africa, Britain, and Kenya - a means, as one of the editors put it, "of preventing the younger members growing up strangers to each other." When war was declared in 1914, the Chronicle began to include letters from family serving in the military and medical corps in diverse contexts, including the war fronts in German East Africa and South West Africa, the trenches of France, and naval battles. News from home continued with accounts of life on a Karoo farm, a horse trek in Basotuland, a leftist political rally in London, and reminiscences of older family members.

She was also the editor of the Heinemann African Writers Series for several years. Staunton has also researched and compiled a number of oral histories including Mothers of the Revolution.

Mothers of the Revolution is one of the most remarkable chronicles to emerge from the Zimbabwean liberation war (1967-1980).

Here are first-hand accounts from rural women living in all parts of the country who stayed behind during the war; the women whose sons and daughters secretly left home to join the liberation armies and sometimes never returned; the women who single-handedly, not only had to keep their homes, but who fed the freedom fighters; women, who as the war intensified, were often caught in the crossfire.

"People said that when the war comes, we are going to fight so that everyone will be rich and the schools will be free ... and there'll be lots of jobs. So, we were looking forward to the war, so that when it was over, we could go to school freely and get jobs very easily."


"If our affairs were now to be decided on how each of us had fought, I can tell you that all the homes would not belong to the women. Men just went away to town and left their women to suffer alone ... they were afraid of being killed. It is the story of the brave wife of one of Kenya's foremost freedom fighters, Field Marshal Dedan Kĩmathi Waciũri. Kĩmathi led the Mau Mau war in Kenya's independence struggle against the British colonialists. Mũkami's role as a daughter, wife, mother, freedom fighter and leader is varied and very complex.

Her story spans pre and post-independent Kenya. Her experiences provide an important complement to existing written literature on Kenya's history. In 2003, the Mwai Kĩbakĩ Government lifted the ban put in place by the British colonialists declaring the Mau Mau as terrorists, and recognised Műkami Kĩmathi and other freedom fighters as national heroes and heroines celebrated on 20th October as Mashujaa Day.

This book gives an insight into the role of women freedom fighters and the struggles they faced both during and after the war. It is an incredible story of immense self-sacrifice and love for Kenya. Műkami provides the lens to see the wider picture of women in the independence struggle, the neglect and betrayal of wives of Mau Mau fighters in particular and women in general in Kenya's making. 





In countries around the world, scientists, policymakers and the public have high hopes for science communication: that it may elevate its populations educationally, that it may raise the level of sound decision-making for people in their daily lives, and that it may contribute to innovation and economic well-being. This collection of current reflections gives an insight into the issues that have to be addressed by research to reach these noble goals, for South Africa and by South Africans in particular.



Placing security studies in the context of contemporary discourses about the "colonial comeback" and posthumanism, this book postulates the notion of staticide which avers that the effacement of African state sovereignty is crucial for the security of the oncoming empire.

Understood in the light of posthumanism, antihumanism, animism, postanthropocentrism and transhumanism; African human security has evidently been put on a recession course together with African state security. Much as African states are demonised as so failed, defective, corrupt, weak and rogue to require recolonisation; transhumanism also assumes that human bodies are so corrupt, imperfect, defective, failed, rogue and weak to require not only enhancements or augmentation but also to beckon recolonisation. Also, deemed to be ecologies, human bodies are set to be liberalised and democratised in the interest of nonhuman viruses, nanobots, microchips, bacteria, fungi and other pathogens living within the bodies.

The book critically examines the security implications of theorising human bodies as ecologies for nonhuman entities. Reading staticide together with transhumanism, this book foresees transhumanist new eugenics that are accompanying the new empire in a supposedly Anthropocene world that serves to justify the sacrifice and disposability of some surplus humans living in the recesses and nether regions of the empire. Paying attention to the "colonial comeback", the book urges African scholars not to mistake imperial transformation for decolonisation. The book is invaluable for scholars and activists in African studies, anthropology, decoloniality, sociology, politics, development studies, security studies, sociology and anthropology of science and technology studies, and environmental studies.





As an epistemological concept, the shadowlands imply that anthropologists must not only identify these uncanny spaces of junction in their research, but also shadowlands in the ethnographic papers that they produce. In addition to a better understanding of the continuous fabrication of temporalities and being-becoming, the concept puts into perspective the discipline of anthropology itself. Throughout the chapters, the different authors permit to grasp the various applications of the shadowlands, allowing to project the concept in particular contexts and through specific angles of analysis.

The authors of this collection address an overreliance in Anthropology on concepts that reify and fix complex phenomena. While they are part of the three Es, they go further to create a fourth pillar, the institutions, partly to manage complexity as they cause it. The complexity of people as the key definer of sustainability lies in the fact that Homo Sapiens are animals of politics and socio-economic reasoning. As they wrestle in the rationality and decision-making space, natural resources, and any other resources (human, capital, financial and social relations) are configured and reconfigured in such a way that sustainability becomes the major goal under threat.

Using Zimbabwe as a case study, the contributors in this volume dissect development as an endangered species needing the key actors involved to rethink their decisions and actions in the interest of more sustainable and desirable futures.

Situating Open Data Global Trends in Local Contexts

Open data and its effects on society are always woven into infrastructural legacies, social relations, and the political economy. This raises questions about how our understanding and engagement with open data shifts when we focus on its situated use.

To shed light onto these questions, *Situating Open Data* provides several empirical accounts of open data practices, the local implementation of global initiatives, and the development of new open data ecosystems. Drawing on case studies in different countries and contexts, the chapters demonstrate the practices and actors involved in open government data initiatives unfolding within different sociopolitical settings. The book proposes three recommendations for researchers, policy-makers and practitioners. First, beyond upskilling through 'data literacy' programmes, open data initiatives should be specified through the kinds of data practices and effects they generate. Second, global visions of open data implementation require more studies of the resonances and tensions created in localised initiatives. And third, research into open data ecosystems requires more attention to the histories and legacies of information infrastructures and how these shape who benefits from open data flows.

As such, this volume departs from the framing of data as a resource to be deployed. Instead, it proposes a prism of different data practices in different contexts through which to study the social relations, capacities, infrastructural histories and power structures affecting open data initiatives. It is hoped that the contributions collected in Situating Open Data will spark critical reflection about the way open data is locally practiced and implemented. The contributions should be of interest to open data researchers, advocates, and those in or advising government administrations designing and rolling out effective open data initiatives.



In particular it asks: is it possible to view the migration of the Kavango labourers as a progressive step, or does the paradigm of exploitation and suppression remain the dominant one? The study highlights contract labourers engaging in a defeating activity and their disappointment with the little rewards which were non-lasting solutions to their problems. The realization of their entrapment under the contract system and the eventual frustrations led to the political mobilization for independence by SWAPO.





Dina Ligaga is associate professor in the Department of Media Studies, University of the Witwatersrand, South Africa. She has published in the areas of media and cultural studies, and popular culture in Africa, with a specific focus on Kenyan popular culture. She is co-editor of *Radio in Africa* (2011) and *Eastern African Intellectual Traditions* (2012). She is also co-editor of the special issue on 'Gender and Popular Imaginaries in Africa', Agenda, 2018. Women, visibility and morality in Kenyan popular media explores familiar constructions of femininity to assess ways in which it circulates in discourse, both stereotypically and otherwise.

It assesses the meanings of such discourses and their articulations in various public platforms in Kenya. The book draws together theoretical questions on 'pre-convened' scripts that contain or condition how women can circulate in public. The book asks questions about particular interpretations of women's bodies that are considered transgressive or unruly and why these bodies become significant symbolic sites for the generation of knowledge on morality and sexuality. The book also poses questions about genre and representations of femininity. The assertion made is that for knowledges of femininity to circulate effectively, they must be melodramatic, spectacular and scandalous. Ultimately, the book asks how such a theorisation of popular modes of representation enable a better understanding of the connections between gender, sexuality and violence in Kenya.



The increasing scarcity of land as scarce commodity and African land ownership in Evaton, best explains the history of African local economic independence. For the local residents, land possession in Evaton provided a space where a moral economy that fostered racial pride and solidarity was forged. This richly sourced monograph develops the logical explanation that sticks together all forces that constrained Africans to give up labour to an industrial economy in Evaton. It provides the reader and student of racialised inequalities in South Africa with an understanding steeped in historical ethnography on how local Africans struggled for economic independence, and how whatever independence their struggles yielded, changed over time in Evaton.

Our History

In 1985 a group of publishers met to address the constraints they were experiencing in marketing and distributing their books outside of their domestic markets. They founded ABC as a collective self-help initiative to strengthen their economic base and meet the needs of libraries and other book buyers. With initial support from funding agencies, trading began in 1989. Major remodelling of the collective took place in 2007, when it became self-financing. New opportunities afforded by the evolution of digital publishing and electronic books were seized upon, with ABC playing a key role in the digitisation of African cultural output. While adapting to changing markets and methodologies, ABC's founding ethos and aims remain unchanged, and ABC remains a not-for-profit organisation on its own behalf.
