


In *Cultivating Moral Citizenship*, ethnographer Jude Fokwang unpacks the meanings, mechanisms and processes through which young people in an inner city of the West African nation of Cameroon respond to local and global challenges as they seek to position themselves as social adults. Faced with the decline of old predictabilities, the diminishing capacity of the postcolonial state to control its destiny and the precarity of waithood, young people instrumentalise the opportunities and resources afforded by associations to build reciprocal relationships that advance their individual and collective pursuits in a community that has increasingly become transnational. In positioning themselves as moral actors, the young people in this ethnography invest in high profile social and communal projects, including the enforcement of moral orthodoxies that enable readers to appreciate the ways in which moral citizenship is engendered, expanded and eroded simultaneously.

Obesity in Women


The Double Burden of Malnutrition has become a major global problem particularly in the so-called low- and middle-income countries because of the rapidly increasing prevalence of obesity and overweight, particularly in women – as indicated by the Body Mass Index (BMI), alongside the slow decreases in the long-standing problems of hunger and childhood undernutrition. That BMI may underestimate the extent body fat and associated risks in some populations is well documented. However, the possibility for BMI to overestimate the degree of body fat and the associated health risks in some populations is not as well documented.

This book details how women in Uganda have developed their own sense of an ideal body size which is not so small as to be associated with communicable disease, and not so fat as to put them at a risk for non-communicable disease; in a way that is different from the global standards. It further details the daily activities of women in urban Uganda as they pertain to physical activity level and energy requirement, as well as detailing how the past and present socioeconomic circumstances interact to shape women's food consumption practices, attitudes and beliefs; and how these might predispose women to obesity.



Authoritarianism and Attacks on the Arts in Sudan's 30 Years of Islamist Rule Ruba El Melik and Reem Abbas




In April 2019, when millions marched to the headquarters of the military in Khartoum and other cities and the march was transformed into a sit-in that continued for two months, the sit-in became Sudan's largest arts festival. The art produced during the revolution went viral, as it was covered by foreign journalists who swarmed Khartoum to report on the revolution. However, the narrative was always lacking the historical significance of how art was mobilized. Sudan's contemporary art history was nurtured by its many revolutions; in 1964, in 1985 and in 2018/19. Due to the military dictatorships that continued to rule Sudan since independence, art was always positioned as a revolutionary product.

To contextualize the revolutionary art produced and consumed during the 2018/19 revolution, this book explores Sudan's contemporary history by briefly looking at the politically turbulent 1980s and deeply looking at how culture and art were policed in the dark 1990s. During that period, the entire artistic and cultural landscape came under attack as artists were arrested, sacked from jobs and intimidated, but the infrastructure that has always supported this landscape suffered the most, as the book hopes to explain.




The infamous "Scramble for Africa" resulted in random and unlikely borders that remain today. The West partitioned territory for the sake of its short-term goal of influence or mastery. They gave little thought to the long-running consequences for the Africans themselves. This colonial policy of divide and rule, and the resultant segmental cleavages in most post-colonial African states, may be blamed for the horizontal inequalities, conflicts, and insecurity rampant since independence.

This book highlights the dynamics of ethnic politics in the post-independence sub-Saharan setting in general and the background, meaning, and relevance of the debate on ethnic federalism in Uganda, in particular. Part of the book covers Vick Lukwago Ssali's own experiences growing up in an independent but troubled Uganda. However, its central thesis is based on the voices of selected samples of ordinary people in ten different tribal areas of Uganda and what they think about the issue of federalism. Is their loyalty growing towards the centre or fading outwards from the troubled state to their integral traditional and cultural units?




For over 30 years, Willy Mutunga has blazed the trail in starting many important public conversations about remaking Kenya and the wider world into a better society. As a public intellectual, he has consistently challenged convenient stereotypes in an effort to bring down the social barriers erected by fear and ignorance, and led in persuading individuals and communities to re-examine widely held prejudices and to start difficult dialogues. Between 2006 and 2011, Mutunga wrote a weekly column in the Saturday Nation. It is from these contributions, under the pen name Cabral Pinto – a combination of the surnames of the two African ideologues he greatly admired — that the 146 articles in this volume are selected. The clarity of Willy's moral voice is unmistakable on a broad variety of themes, ranging from exhortations for an alternative leadership that would deliver a human rights state, to an unapologetic call for mass action as a peaceful way to bring change. This collection by Cabral Pinto is the story of Kenya's long democracy struggle, told by a pro-democracy activist.



Enslaved: Trapped and Trafficked in Digital Black Holes

Human Trafficking Trajectories to Libya


Eritrean refugees are being trafficked and enslaved in Libya, where they are tortured to force relatives to pay a ransom for their release. Labelled with a digital code, they are moved along in the possession of the traffickers through a series of 'black holes', in which their access to digital technologies and connectivity is highly controlled. They are tortured, abused, extorted and subjected to sexual violence. Many die along the way. If they make it to the Mediterranean Sea, they risk being intercepted and returned to Libya or dying at sea. Over the period of this study (2017–21), it is conservatively estimated that at least 200,000 men, women and children have fallen victim to human trafficking for ransom in Libya, and the cumulative value of this trade for that period is estimated at over 1 billion USD. This detailed ethnographic study identifies the routes, modus operandi, organisation, and key actors involved in the human trafficking for ransom of refugees and migrants, who are desperately in need of protection. The book is part of the GAIC Research Network and African studies series published by Langaa RPCIG and makes an important contribution to the literature on human trafficking, migration studies, African studies, modern slavery, social protection and governance.





While these recordings reverberate with the polyphonic echoes of colonial knowledge production, to date, acoustic collections have rarely been consulted as sources of colonial history. In this book Anette Hoffmann engages with a Southern African audio-visual collection, which is located in five different institutions across Vienna, Austria. Several recordings collected by the anthropologist Rudolf Pöch in August 1908 have been retranslated for this book. These translations provide new insights into Pöch's collecting expedition to the Kalahari. Pöch's narrative of his heroic journey is called into question by the Naro speakers' comments, which address colonial violence and criticise the research practices of the anthropologist. By attending to the spoken texts on the recordings and reconnecting them to photographs, ethnographic objects, archival documentation and Pöch's travelogue, Hoffmann offers a different reading of this research trip into a war zone.





Research into the history of Christian missions in the context of colonialism has focused primarily on missions as institutions and on the ways in which people were integrated into the economic, political and ideological spheres of imperial powers. Reduced to an experience occurring within a person, faith was deemed unapproachable by scientific methods. This has, in effect, constituted a silence regarding the everyday experience of religiosity amongst those drawn to Christianity.


Ethnography of Faith is a detailed study of the ways in which people engage with and experience the religious in order to recognise and understand this suppressed voice of religiosity. In her analysis of the Lutheran church in the Soutpansberg of early twentieth century South Africa, Caroline Jeannerat listens closely to how people describe their own faith and that of others in the archive: in accounts of work done, in texts written for mission publications, in songs composed for church services, in letters and newspaper articles and in oral memories. A careful reading of this archive – for breaks, for misunderstandings and oppositions, for sentiments of agreement, praise, compatibility and claims of shared experiences – identifies negotiations of meaning which give indications of conceptualisations of faith that stand in distinction to those of the missionaries and their expectations.

In 1985 a group of publishers met to address the constraints they were experiencing in marketing and distributing their books outside of their domestic markets. They founded ABC as a collective self-help initiative to strengthen their economic base and meet the needs of libraries and other book buyers. With initial support from funding agencies, trading began in 1989. Major remodeling of the collective took place in 2007, when it became self-financing. New opportunities afforded by the evolution of digital publishing and electronic books were taken advantage of, with ABC playing a key role in the digitization of African cultural output. While adapting to changing markets and methodologies, ABC's founding ethos and aims remain unchanged, and ABC remains a not-for-profit organisation on its own behalf.
